GENERAL RULES

HB pg. 24

This Flower Show conforms to the standards established by National Garden Clubs, Inc. (NGC). *The Handbook for Flower Shows (HB),* **2017 edition**, with revisions printed in *The National Gardener Magazine* (TNG), is the authority for all issues not covered by the schedule, which is the law of the show.

- **1.** Current horticultural reference books and websites will be consulted for Classification as available.
- 2. Competition in the Design and Botanical Arts Divisions is open to all members of the Garden Club of St. Petersburg, Inc. and to all amateur exhibitors who are members of Florida Federation of Garden Clubs, Inc.
- 3. Competition in Horticulture is open to all members of the Garden Club of St. Petersburg, Inc. and all amateur exhibitors in Florida. Non-members may enter no more than five (5) horticulture exhibits.
- **4.** Design entry forms are available from the Entries Chairman (Jill Anderson, 798-1970, jillandersn@aol.com) and the

appropriate Design Entry Consultant for each section. The Horticulture entry forms are available from the Entries Chairman (Mary Pat Troy: gardenmp@gmail.com, 204-4285). In addition, the Flower Show Schedule and all entry forms are available online at Gardenclubofstpetersburg.org and at the Garden Club, 500 Sunset Drive South.

- 5. ALL entries should be registered in advance with the Division/Section Consultants prior to April 10, 2024 and all cut specimens by April 20, 2024 with the Entries Chair as listed in the Schedule either by email or in writing in order to be computerized. Entry cards will be computer generated by committee.
- **6.** Consult the rules for each Division for more specific information.
- **7.** Entries will be accepted at Walter Fuller Park Community Center, 7891 26th Avenue North, St. Petersburg, Florida 33710 according to the following schedule:

THURSDAY, APRIL 25

Horticulture from 10am - 2pm Design, Botanical Arts and Education from 1pm - 5pm

FRIDAY, APRIL 26

Cut Horticulture specimens from 9am-10am Design Entries from 9am - 10am *by permission*

Persons wishing to make entries not in accordance with this schedule *MUST* have permission from the Division Entries Chair.

- **8.** An awards ceremony will be held Sunday, April 28 at 3pm at Walter Fuller Park Community Center, 7891 26th Avenue North, St. Petersburg, Florida 33710. Exhibits are to be removed immediately following the awards ceremony.
- **9.** Judging will begin at 1pm on Friday, April 26. Judging will be by National Garden Club accredited judges.
- 10. The Classification Chair for each division checks exhibits for conformity to the schedule prior to judging. Final determination for conformance is the judge's responsibility. Exhibitors must have entries checked before leaving the area.
- **11.** The Flower Show Chair and the Classification Chair for each Division are available during judging for possible consultations. They, along with the judges and clerks, are the only personnel allowed on the floor during judging.

- **12.** All exhibitors must leave the show area by 11am on Friday, April 26.
- 13. The decision of the judges is final. Awards may be withheld if not merited. The NGC Standard System of Awards will be used in all divisions. Judging is done using Scales of Points based on perfection (100 points). Scales of points are composed of qualities or categories with numerical values based on relative importance of the qualities to each other. Scales of Points for all competitive exhibits are found on pages 129-138 of The *Handbook for Flower Shows*, Revised 2017.

There must be an emphasis on FRESH plant material. NO artificial plant material is permitted in any exhibit in any Division.

- **14.** Each exhibitor is limited to one entry per class, except in the Horticulture Division and the Botanical Arts Horticulture Section.
- **15.** The Garden Club of St. Petersburg, Inc. flower show committee will strive to assure the safety of all items after arrival and placement but is not responsible for any loss or damage to exhibits. No design or horticulture entry will be disposed of without notification.
 - Native plant material, correctly labeled and legally obtained within the state of Florida may be entered and displayed. The use of plant material classified as Invasive Exotic or Aquatic Invasive is prohibited. See the IFAS website at the Center for Aquatic and Invasive plants,

16. The use of plant material on Florida's Federally Listed Plant Species as endangered or threatened is prohibited. See the list at:

AWARDS

PURPOSES OF NGC STANDARD SYSTEM OF AWARDING

- Encourages uniform standard of judging.
- Ensures fair and objective evaluation of all exhibits.
- Ensures no criteria are overlooked.
- Compares relative importance of qualities.

THE NGC STANDARD SYSTEM OF AWARDING HB p. 5

Scales of Points are based on **perfection** (100 points)

Each exhibit is evaluated individually.

Exhibits are ranked by the points they receive.

THE NGC STANDARD OF AWARDING IS USED IN ALL DIVISIONS

- Only one (1) first place (blue) ribbon per class or subclass; must score 90 points or more.
- Only one (1) second place (red) ribbon per class or subclass; must score 85 points or more.
- Only one (1) third place (yellow) ribbon per class or subclass; must score 80 points or more.
- One (1) or more honorable mention (white) ribbons as merited; must score 75 points or more.

Award must be withheld if the exhibit does not meet the point value for the ribbon. Entry cards of Blue ribbons and 90+ exhibits must be signed and dated by an NGC Accredited Judge on the panel. All other entry cards must be initialed (Accredited Judge or Student Judge may initial). Top Exhibitor award rosettes must be signed on the back by an NGC Accredited Judge who judged the class. HB p. 6.

ALL NGC AWARDS MUST BE HIGHEST SCORING 95+ BLUE RIBBON WINNER.

DESIGN TOP EXHIBITOR AWARDS

Division must include at least two (2) or more sections. Each section must consist of three (3) or more classes.

Minimum of 20 classes total with at least 4 exhibits in each class.

AWARD OF DESIGN EXCELLENCE

One (1) in Division I, Sections A-C Classes 1-9 Rosette of gold ribbons

DESIGNER'S CHOICE AWARD in Section A, Classes 1-3 One (1) Rosette of purple ribbons

> **PETITE AWARD** in Section B, Classes 4-6 One (1) Rosette of blue and white ribbons

TABLE ARTISTRY AWARD in Section C, Classes 7-9 One (1) Rosette of burgundy ribbons

DIVISION II – HORTICULTURE HB. pp. 40-41

HORTICULTURE TOP EXHIBITOR AWARDS

Division must include at least two (2) or more sections. Each section must contain at least three (3) specific classes. Minimum of 20 classes total with a minimum of 80 exhibits total. No minimum number of exhibits is required per class.

AWARD OF HORTICULTURAL EXCELLENCE

One (1) in Division II, Sections A-M, Classes 1-145 Rosette of green, blue and orange ribbons

ARBOREAL AWARD

AWARD OF MERIT

Classes 105-122 Rosette of green ribbons

One (1) in each Section: J & K, One (1) in each Section: L & M, Classes 123-145 Rosette of orange ribbons

GROWERS' CHOICE AWARD

One (1) in each Section: A, B, C, D, E, F, G, H, & I, Classes 1-104 Rosette of dark green ribbons

DIVISION III- BOTANICAL ARTS HB pp. 44-45

BOTANICAL ARTS ARTISTIC CRAFTS AWARD

Section must consist of at least three (3) classes with at least four (4) exhibits in each class. One (1) in Section A, Classes 1-3 Rosette of navy blue ribbons

BOTANICAL ARTS PHOTOGRAPHY AWARD

Section must consist of at least three (3) classes with at least four (4) exhibits in each class. One (1) in Section B, Classes 4-6 Rosette of black and white ribbons

BOTANICAL ARTS HORTICULTURE AWARD

Each section must consist of at least three (3) classes with at least twelve (12) exhibits in all classes combined.

One (1) in Section C, Classes 7-10

Rosette of light brown ribbons

DIVISION IV- YOUTH YOUTH TOP EXHIBITOR AWARD

One for each age group in Horticulture and Design.
One (1) in each class in Section A, Classes 1 & 2

Rosette of red, white and blue ribbons

<u>DIVISION V– EDUCATION</u> HB pp. 43 & 44 EDUCATIONAL TOP EXHIBITOR AWARD

A minimum of two (2) educational exhibits required.
One (1) in Section A, Exhibits 1 & 2
Rosette of brown and white ribbons

PURPOSE OF AN NGC FLOWER SHOW

To educate club members and the viewing public
To stimulate interest in horticulture and floral design
To provide an outlet for creative expression
To communicate NGC goals and objectives

DIVISION I - DESIGN RULES

HB pp. 28-29, 79-81

- 1. The NGC Exhibit Policies are printed in the *Handbook of Flower Shows*, Chapter 7, Exhibiting in the Design Division, NGC Policies and Guidelines.
- 2. Advance registration is required by **April 10, 2024.** Submit entry forms to the Design Entries Chair, Jill Anderson, jillandersn@aol.com or mail to 8014 12th Ave. S, St. Petersburg, FL 33707. If an entry is to be placed on Friday, April 26, the exhibitor must notify the Section Consultant ahead of time.
- 3. Some plant material must be used in every exhibit. This includes fresh and/or dried plant material. Plant material need not have been grown by the exhibitor.
- 4. Entry cards will be placed at the exhibitor's exhibit space by committee. To educate the public, all plant material used in the design **must** be identified on a 3x5 card and placed next to the Design entry card. Index cards will be provided by the Committee. Botanical and/or common names are acceptable. A brief interpretation of the design may be included on the card. When design techniques are required, they must be listed on the card.
- 5. Exhibitors are required to conform to the stated descriptions and limitations of the Design Type, if named in the class.
- 6. Rules for Design Types, Advanced Design Types, Table Designs and Table appointments are found in the *Handbook for Flower Shows*, Chapter 7.
- 7. Designer is on his/her honor that the design being entered has not been previously entered or judged in an NGC Standard Flower Show.
- 8. Design classes are limited to four entries each. An exhibitor may enter multiple classes within the Design Division, but only one (1) exhibit per class.
- The exhibit entered into competition must be the work of only one (1) exhibitor and that exhibitor's name must appear on the entry card.

- 10. If the designer is unable to fulfill the assignment, it is the designer's responsibility to provide a substitute and advise the Design Entries Chair.
- 11. If the designer is unavailable to transport and/or set up her/his completed design, a substitute person may enter the exhibit for the designer. This is permitted only for **completed designs**.
- 12. A single flower or a container grown plant is not a "design".
- 13. Landscapes, scenes, or anything representing an actual item of clothing, person, animal, etc., are not considered acceptable in the Design Division. These items are exhibited in the Botanical Arts Division.
- 14. Religious symbols used in a design must be displayed in a respectful manner.
- 15. No height requirement unless otherwise stated.
- 16. All design exhibits are judged directly center-front at least three (3) feet from the exhibit, unless otherwise stated in the schedule.
- 17. The following are furnished by the Flower Show Committee unless noted otherwise:
 - a. All backgrounds are black pipe and drape unless stated otherwise in the schedule.
 - b. All staging is provided as needed.
- 18. Design must be approved for conformance by the Section Design Consultant <u>before</u> the exhibitor leaves the show area. Exhibitors are expected to maintain their exhibits for the duration of the show. Refreshing of plant material will only be allowed from 9 am to 10 am on Friday, April 26 and from 8:30 am to 9:30 am on April 27 & 28. *Replacement materials must not alter the design.*
- 19. The designer has the freedom to choose Traditional or Creative style with any design listed unless restricted by the schedule.

PLANT MATERIALS IN THE DESIGN DIVISION HB pp. 80-81

Unless prohibited by the schedule, law, or specific requirements of a Design Top Exhibitor Award:

1. **PERMITTED:**

a. Products manufactured from plant material whose natural state (leaves, branch, tree trunk, root, etc.) have been so

- altered as to be given a new identity and a specific name, such as rope, basket, mat, etc.
- b. Decorative wood: An all-inclusive term for most dried wood that includes weathered wood and/or polished or otherwise treated wood. Not permitted in Tricolor classes.
- c. Altering the exterior appearance of dried plant material.
- d. Using absorbing solutions such as glycerin, bleach, anti-freeze, etc. on fresh plant material to change the natural dried state.
- e. Contrived plant material (a form constructed of fresh and/or dried plant material appearing as an obvious "fantasy flower", foliage and/or stem).
- f. Dried man-made constructed components retaining their recognizable character as plant material (and not used as a container), such as grape vine forms, etc. are considered dried plant material.
- g. Living plants with roots attached, such as moss, Bromeliaceae family members or container grown specimens.
- h. Plants on state conservation/native plant list, grown by the exhibitor or obtained in a legal manner and so identified.
- i. Fresh plant material may be clipped, stripped, bent, or otherwise manipulated.
- Non-perishable food products and cut fruits or vegetables must be sealed to discourage insects, odors, and discoloration.

2. NOT PERMITTED:

- a. Painting, flocking, glittering, or dying of fresh plant material in any manner. (All other physical embellishments or fresh plant material are permitted.)
- Artificial flowers, foliage, fruits, and vegetables. (Artificial is defined as "imitation" or a "copy", handcrafted or manufactured to represent and/or appear as real plant material.)
- c. Silk, plastic, or imitation plant material.
- d. Manufactured items simulating plant material. (Examples -singing/speaking flowers, motorized flowers and metallic flowers and foliage, fountains featuring metal cattails and/or waterlilies.)

e. Invasive plants; See the list at: http://www.floridaforestservice.com/forest_management/pl ant conserve list.html.

NON-PLANT MATERIAL IN THE DESIGN DIVISION

Unless prohibited by the schedule, law, or specific requirements of a Design Top Exhibitor Award:

PERMITTED:

- a. Accessories (a subordinate object other than plant material) and featured objects (an object that is dominant in a design).
- b. Dinnerware, inspired in design by the form of a plant (flower, fruit, leaf, vegetable, etc.) created not to replace the actual plant material, but to serve as an interesting piece of dinnerware.
- Objects adding interest when permitted by federal, state and/or local regulations, such as feathers, antlers, coral, horns, starfish, sponges, sea fans, shells, nests, or manufactured or crafted simulations of birds, animals, etc.
- d. Special lighting not requiring an electrical source.
- e. All staging properties, such as panels including staging panels, frames, pedestals, columns, boxes, cubes, underlays, etc.

NOT PERMITTED:

- a. American and other national flags.
- b. Living members of the animal kingdom and/or taxidermal representations.

DIVISION I: DESIGN - "ROAD TRIP"

Eligible for the Award of Design Excellence HB p. 42

SECTION A. "SING-ALONG TUNES"

The best sing-along songs are those that create unforgettable moments, bridging generations with melody and rhythm.

Eligible for one Designer's Choice Award - *HB* p. 47

Plant material in the exhibit may be dried, treated dried and/or fresh. Background is black pipe and drape unless otherwise stated.

CLASS 1: "Take Me Home, Country Roads" 4 Exhibits

Written by John Denver, this song became one of the four official state anthems of West Virginia in March 2014.

A Creative Design - HB p. 73

Designer has complete freedom in choice of plant material and design.

- Staged on a section of a 29" high, 6' table, covered in black.
- Exhibitor to provide a two-dimensional staging panel, 48" high, not to exceed 32" wide.
- Underlay is optional, not to exceed the edge of the table.
- Frame of Reference: 32" wide x 30" deep x 48" high.

CLASS 2: "On The Road Again" 4 Exhibits

Willie Nelson's song about life on tour was a No. 1 hit, becoming one of his most recognizable tunes.

A Creative Multi-Rhythmic Design - HB p. 75

A Creative Design with emphasis on two (2) or more rhythms in the design with one (1) rhythm dominating. Lines create two (2) or more separate and distinct rhythms, each creating a different pattern and movement unlike the other. Lines may go in any direction, be continuous, interrupted and/or crossed.

- Staged on a 32" high natural wood pedestal with a 24" square top.
- The top to be covered by the designer.
- Frame of Reference: 30" wide, no height restriction.

CLASS 3: "I Can See Clearly Now"

4 Exhibits

"I Can See Clearly Now" is an album by the American singer Johnny Nash, released in 1972.

A Creative Transparency Design - HB p. 77

A Creative Design with see-through elements (translucent, diaphanous, grid-like materials, etc.) integral to the design and permitting some components to be viewed through others.

- Staged on a section of a 6' table covered in black.
- The background is light blue fabric.
- Frame of Reference: 32" wide x 30" deep. No height restriction.

SECTION B. "ARE WE THERE YET?"

What child or adult hasn't said those words in anticipation when on a vacation or adventure?

Eligible for one Petite Award - HB p. 47

Designer's Choice: Plant material in the exhibit may be dried, treated dried and/or fresh.

Background is black pipe and drape unless stated otherwise.

CLASS 4: "Here Comes The Sun"

4 Exhibits

A Beatles rock song from their 1969 album, Abbey Road, was written by George Harrison at the country house of his friend Eric Clapton.

8" Creative Design - HB p. 71

Designer has complete freedom in choice of plant material and design.

- Exhibitor to provide a staging panel not to exceed the Frame of Reference. An underlay may be used.
- Staging: On a section of a bistro table covered in black.
- Frame of Reference: 8" wide x 8" deep x 8" high.

CLASS 5: "Bridge Over Troubled Water" 4 Exhibits

This American folk rock song, written by Simon & Garfunkel, topped charts in over ten countries and in 1971 received six Grammy Awards including the Album of the Year.

10" Creative Underwater Design - HB p. 75

A Creative Design having some or all plant material and other optional component/s submerged in water. Plant material and other components under water must contribute to the overall design and are selected for their lasting quality.

- Staged: On a white shelf 12" high, 12" deep and 52" wide, placed on a fireplace mantle.
- Frame of Reference: 10" wide x 10" deep x 10" high.

CLASS 6: "Going In Circles"

4 Exhibits

Sung by The Friends of Distinction is about feeling stuck in a constant cycle of uncertainty, confusion, and desperation.

12" Creative Reflective Design - *HB* p. 75

A Creative Design containing reflective materials giving back images of light to the viewer. The reflective materials are an integral part of the overall design. Staging in front of a mirror is not acceptable.

- Staged: On a section of a bistro table covered in black.
- Exhibitor to provide a two-dimensional staging panel, 12" high, not to exceed 12" wide.
- Underlay is optional, not to exceed the edge of the table.
- Frame of Reference: 12" wide x 12" deep x 12" high.

SECTION C. "STOP AT THE FARMERS MARKET"

Locally grown produce at the farmers market is often sold at the peak of freshness and nutrient content.

Eligible for one Table Artistry Award. HB p. 47

Designer's Choice: Plant material in the exhibit may be dried, treated dried and/or fresh. Background is black pipe and drape unless otherwise stated.

CLASS 7: "Fresh From The Grower"

4 Exhibits

More than 85% of farmer's market vendors travel fewer than 50 miles to sell at a market.

A Casual Functional Table for Two - HB p. 76

- Staged on a 37" square card table 29" high, with white covering, provided by committee.
- Exhibitor may add additional table covering/s.
- Judged from the front.
- Frame of Reference: 32" wide, no height restriction.

CLASS 8: "I Heard It Through the Grapevine" 4 Exhibits

This Marvin Gaye recording is a soul classic, inducted in 1998, into the Grammy Hall of Fame for "historical, artistic and significant" value.

An Exhibition Table - *HB* p. 76

DIVISION II - HORTICULTURE RULES

- **1.** The NGC Exhibit Policies are printed in the *Handbook for Flower Shows*, Revised 2017, Chapter 6, Exhibiting in the Horticulture Division.
- **2.** The rules for a single species cut or container-grown specimen are listed in the *HB*, *pp*. 58, 59, or its supplement, *Horticulture Exhibiting and Judging*.
- **3.** In order to receive an NGC Top Exhibitor Award, the exhibitor must identify his/her entry by its binomial name or currently acceptable scientific designation. Consult *Handbook for Flower Shows*, Exhibiting in the Horticulture Division, Chapter 6.
- **4.** All exhibits must be FRESH. Dried and preserved specimens may be entered in the Botanical Arts-Horticulture Division.
- **5.** All exhibits must have been grown by the exhibitor.
- **6.** Plant material must be in its natural state and may not be altered by application (treatment) of oil, commercial "shine" products, etc. that change the natural appearance. No wiring of specimens is permitted.`
- 7. Only foliage and/or flowers naturally grown and still attached to the specimen are permitted. Unattached foliage is never included with a cut bloom specimen.
- **8.** Plants that grow naturally with multiple stems will be considered one plant. More than one (1) of the same cultivar and color may be combined in the container to improve the overall appearance of the planting. *HB p. 58*
- **9.** Cut specimens should not have foliage below the water line, except for *Gladiolus*.
- **10.** If a plant is considered a flowering plant, it should be exhibited as a flowering specimen. Foliage plants may flower but should be exhibited as foliage plants if they are grown for their leaves.
- **11.** Specimens with a class designation in the schedule may not be entered in the 'Any Other Worthy' class.
- **12.** The Horticulture Classification Committee Chairman and/or General Show Chairman are free to subdivide classes by color, form, size, cultivar, variety, or other distinguishing characteristics.

- **13.** All entries must be of superior quality, clean, and well groomed. Containers must be clean and appropriate to the plant. Unless specified differently under individual Sections of the Schedule, containers are not to exceed 20 inches in diameter as measured across the top of the container and weigh less than 20 pounds.
- **14.** Double potting is permitted; however, the inner pot must not be visible. Moss is not permissible to cover soil in the pot.
- 15. Exhibitors are required to pre-register entries, except for cut specimens by Wednesday, April 10, 2024, with Horticulture Entries Data Chair, Mary Pat Troy as listed in the schedule.
- **16.** Entry forms are available at the GCSP web site, www.gardenclubstpetersburg.org, in the lobby of the Garden Club of St. Petersburg and from all Entries Chairs who are listed under the Flower Show Committee. A copy of the completed Entry Form should accompany entries.
- **17.** Completed entry forms must be given to the Horticulture Entries Data Chair: Mary Pat Troy by email to: gardenmp@gmail.com OR mailed to 12229 93rd. St., Largo, FL 33773.
- **18.** Entry cards will be computer generated by committee.
- 19. Entries MUST be delivered to the Walter Fuller Park Community Center, 7891 26th Ave. N, St. Petersburg, FL on Thursday, April 25, 2024 between 10am and 2pm. Registered CUT specimens only will be accepted from 8am to 10am on Friday, April 26, 2024.
- **20.** The Horticulture Classification Chairman or Committee must approve all entries before they are placed. They may disqualify any entry that does not conform to the Schedule or that is of inferior quality.
- **21.** After approval by the Horticulture Classification Chair, the exhibit will be placed by the Placement Committee, unless stated differently in the schedule.
- **22.** Exhibitor may enter more than one entry per class but NOT of the same variety, cultivar, type, size, or color, unless stated otherwise in the schedule.
- **23.** Flower Show committee will furnish clear, colorless, glass containers for cut specimens.

- **24.** Clear plastic wrap and/or marbles will be provided by committee for wedging and anchoring material.
- **25.** All exhibits will be placed on tables with black floor length covers with light blue plastic top cover. Plants may be placed at different heights with various staging and table coverings. The staging committee will provide proper staging for these entries (elevated plant stands, pedestals, etc.)
- **26.** All entries must be named by genus, species and variety or cultivar if applicable. Common names, if known, may be listed. In order to receive an NGC Top Exhibitor Award, the exhibitor must identify her/his entry by its binomial name and or currently acceptable scientific designation. Classification and labeling of entries will be based on the rulings of https://powo.science.kew.org/.
- **27.** Current horticultural reference books and websites will be consulted for Classification.
- **28.** All plant material must have been in the possession of the exhibitor for the appropriate number of days. SEE LIST BELOW:

- **5.** The NGC Exhibit Policies are printed in the *Handbook for Flower Shows*, Revised 2017, Chapter 9, exhibiting in the Youth and Sponsored Groups Division, NGC Policies and Guidelines.
- **6.** All youth exhibits are judged using the standard Scales of Points for Horticulture and Design.

DIVISION V - EDUCATION RULES HB p. 29

- 1. All General rules apply.
- **2.** Education Exhibits may be the work of more than one (1) individual or organization unless a Student Judge or an Accredited Judge is seeking exhibiting credit for preparing an education exhibit.
- **3.** To be eligible for an NGC Educational Top Exhibitor Award, a minimum of eighteen (18) square feet of surface area must be used.
- **4.** Staged on a 6' table, 29" high and 30" deep, with a black floor length cover, provided by committee.
- **5.** Exhibit should include a display board/trifold measuring 36" high.
- **6.** Exhibits should inform members and the public about the goals and objectives of NGC.
- 7. The National Garden Clubs' Standard System of Awarding will be used.
- 8. Registration will be in advance with the Education Division Chair, Jan Ankerberg, jlankerberg@gmail.com by April 10, 2024.
- 9. No artificial plant material is permitted in an Education Exhibit.
- **10.** Exhibits should convey educational facts quickly and persuasively in an interesting manner. Displayed printed material should be large enough to read from a distance of three (3) feet.
- 11. Handout materials add to educational value but are not required.
- **12.** Educational value is the most important consideration.
- **13.** Entries will be placed on April 26, 2024, 1-5pm at Walter Fuller Park Community Center, 7891 26th Avenue North, St. Petersburg, Florida 33710.
- **14.** Exhibits to be removed April 28, 2024, immediately following the awards ceremony at 3pm.

GREEN THUMB FESTIVAL

The Green Thumb Festival was established by the City of St. Petersburg's Parks Department as an Arbor Day celebration on April 11, 1986, at Boyd Hill Nature Preserve. The concept was introduced by the Parks Director at the time, Litdell "Dell" Holmes, to meet the requirements of the prestigious Tree City USA award, and as a result, the City has been a recipient of the award every year since 1986.

Festival attendance is estimated at 30,000 to 35,000 over the two-day event and more than 200 educational and environmental exhibits and vendors participate. The festival continues to be free of charge.

To promote tree planting and beautification, the Festival gives away free pine seedlings and more than 1,000 free plants each year. Food and entertainment round out the Green Thumb Festival to make it an event the whole family can enjoy.

We hope you will enjoy this festival that promotes respect for nature and our environment. It offers opportunities to learn more about the care and cultivation of plants and flowers through the Garden Club of St Petersburg's annual flower show that includes horticulture exhibits, floral designs, and educational displays. Outside there are over 200 plant-centric vendors and educational booths from the city and county offices.
